4.1 Description of necessary first aid measures

5.1 Extinguishing media

Suitable extinguishing media: Use water spray, alcohol-resistant foam, dry chemical or carbon dioxide.

5.2 Specific hazards arising from the chemical

Specific hazards during firefighting: Do not use a solid water stream as it may scatter and spread fire. Flash back possible over considerable distance. May form explosive mixtures in air. Carbon oxides.
